On February 11, 2019, the Commission issued an order directing Wisper to remedy a defect in its application pursuant to Commission Rule 4 CSR 2.060(1)(M), by submitting an affidavit verifying the truthfulness of the application. This requirement is also contained in Commission Rule 4 CSR 240-31.016(2)(A). The original application was accompanied by an affidavit verifying the Notice of Transfer of Control, but no affidavit verifying the application. Failing to immediately file an affidavit regarding Wisper's application will result in the Commission being unable to issue an order regarding Wisper's application that would be effective before February 25, 2019.

**THE COMMISSION ORDERS THAT:**

1. Wisper ISP Inc. is ordered to immediately submit an affidavit verifying its application for designation as a wireless Eligible Telecommunications Carrier.

2. This order shall be effective when issued.
