**ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF**

Issue Date: February 13, 2019

Effective Date: March 1, 2019

On January 15, 2019, KCP&L Greater Missouri Operations Company (GMO) filed the pending tariff sheet, Tariff No. YH-2019-0148, setting forth the quarterly cost adjustment (QCA) for the fourth quarter of calendar year 2018. On January 30, 2019, Staff recommended the tariff sheet be approved or allowed to go into effect by operation of law.

In its verified recommendation, Staff states that it has reviewed the tariff sheet and the mathematical calculations GMO provided and is of the opinion that GMO has calculated the QCA for the fourth quarter of 2018 in accordance with the appropriate tariff provisions. Staff recommends the Commission approve the proposed tariff sheet or allow it to become effective by operation of law. No other responses to the tariff sheet were filed.

The Commission has reviewed GMO's tariff sheet and Staff's verified recommendation. Based on these filings, the Commission finds that the tariff sheet is in compliance with the Commission's previous orders and GMO's current tariff provisions. The Commission approves the tariff sheet as ordered below.
