**ORDER DIRECTING NOTICE AND SETTING DATES FOR SUBMISSION OF
INTERVENTION REQUESTS AND STAFF RECOMMENDATION**

On February 12, 2019, Elm Hills Utility Operating Company, Inc. ("Elm Hills") filed an application with the Missouri Public Service Commission requesting that the Commission grant it a Certificate of Convenience and Necessity to acquire, own, install, construct, operate, control, manage and maintain a sewer system in Pettis County, Missouri, in an area known as Stone Creek near the city of Sedalia. The requested Certificate of Convenience and Necessity would allow Elm Hills to acquire and rehabilitate a claimed nonviable utility. The Commission will direct that notice be given and set a deadline for intervention requests and Staff recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commission of Pettis County, Missouri, the City Council of Sedalia at Sedalia City Hall, 200 South Osage Avenue, Sedalia, Missouri 65301, and the Missouri Department of Natural Resources.
2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the members of the General Assembly representing Pettis County, Missouri and to the media serving Pettis County, Missouri.

3. Any application to intervene shall be filed no later than March 6, 2019.
4. The Commission's Staff shall file a recommendation regarding Elm Hills Utility Operating Company, Inc.'s application no later than April 15, 2019.
5. This order shall be effective when issued.
