ORDER ESTABLISHING TIME TO RESPOND TO REQUEST FOR VARIANCE

Union Electric Company d/b/a Ameren Missouri filed a request for variance and motion for expedited treatment on February 13, 2019. Ameren Missouri asks the Commission to grant it a variance from provisions of the Commission's affiliate transaction rules to allow it additional time to file annual affiliate transaction information required by the rule. The rule would require that information be filed by March 15, Ameren Missouri asks to delay that filing until May 15.

Because it would need to promptly gather information to meet the March 15 filing deadline if a variance is not granted, Ameren Missouri asks the Commission to approve its requested variance by February 20. Ameren Missouri indicates it has consulted both Staff and Public Counsel, and represents that neither object to the requested variance.

The Commission will establish a time for filing any responses to Ameren Missouri's request.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to Union Electric Company d/b/a Ameren Missouri's Request for Variance from 4 CSR 240-20.015(4)(B) and 4 CSR 240-40.015(4)(B) shall do so no later than February 19, 2019.

2. This order shall be effective when issued.
