On February 11, 2019, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") filed status reports. The status reports state that KCP&L, GMO, the Commission's Staff, and the Office of the Public Counsel are engaged in ongoing settlement discussions. KCP&L and GMO ask for an additional 30 days to negotiate. KCP&L and GMO state that neither Staff nor the Office of the Public Counsel objects to an additional 30 days. The Commission will order the parties to file a settlement or status report by March 13, 2019.

**THE COMMISSION ORDERS THAT:**

1. The parties shall file a settlement or status report no later than March 13, 2019.

2. This order shall be effective when issued.


