On April 15, 2014, Kansas City Power & Light Company ("KCPL") filed with the Missouri Public Service Commission ("Commission") its 2013 Annual Renewable Energy Standard Compliance Report pursuant to Commission Rule 4 CSR 240-20.100. On the same date, KCPL also filed a Request for Waiver of Commission Rule 4 CSR 240-20.100(7)(A)1.I(V).

The Commission will give notice and establish a deadline for Staff to file a report and for other interested entities to file comments regarding the 2013 Annual Renewable Energy Standard Compliance Report. The Commission will also establish a deadline for any entities wishing to respond to the Request for Waiver.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve a copy of this order upon each party to File Numbers ER-2012-0174 and EO-2013-0504.
2. The Commission's Data Center shall serve a copy of this order upon the county commission of each county within Kansas City Power & Light Company's service area.

3. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing Kansas City Power & Light Company's service area and to the news media serving that service area.

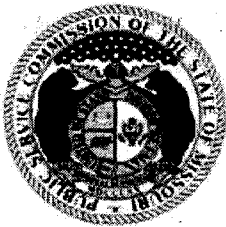
4. The Staff of the Missouri Public Service Commission shall examine Kansas City Power & Light Company's 2013 Annual Renewable Energy Standard Compliance Report and file a report of its review no later than May 30, 2014.

5. No later than May 30, 2014, the Office of the Public Counsel and any other interested person or entity may file comments regarding Kansas City Power & Light Company's 2013 Annual Renewable Energy Standard Compliance Report.

6. Any person or entity wishing to respond to Kansas City Power & Light Company's Request for Waiver of Commission Rule 4 CSR 240-20.100(7)(A)1.I.(V) shall do so no later than April 25, 2014.

7. This order shall become effective immediately upon issuance.




