ORDER GRANTING VARIANCE

Issue Date: February 20, 2019

Effective Date: March 2, 2019

Under the Commission's affiliate transaction rule (4 CSR 240-20.015(4)(B) for electric and 4 CSR 240-40.015(4)(B) for gas), Union Electric Company d/b/a Ameren Missouri is required to provide affiliate transaction information on a calendar year basis to the Commission's Staff and the Office of the Public Counsel on or before March 15 of the succeeding year. Ameren Missouri is required to file corresponding affiliate transaction information with the Federal Energy Regulatory Commission by April 18. On February 13, 2019, Ameren Missouri requested a variance from the Commission's affiliate transaction rules to allow it to file the affiliate transaction information required by the Commission's rule on May 15 rather than March 15. Ameren Missouri represents that Staff and Public Counsel have been consulted, and do not object to this variance request. Ameren Missouri asked the Commission to rule upon its request by February 20 so that it would know whether it needs to devote the resources needed to comply with the existing March 15 submission date.

On February 14, the Commission ordered that any party wishing to respond to Ameren Missouri's request do so by February 19. No responses have been filed.

4 CSR 240-20.015(10) and 4 CSR 240-40.015(10) allow the Commission to grant a variance from the requirements of those rules. The Commission finds that Ameren Missouri has presented good cause for the variance and will grant the requested relief. Further, the Commission will waive the notice requirements of Commission Rule 4 CSR 240-4.017(1).

THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri's request for variance is granted.

- 2. The notice requirement of Commission Rule 4 CSR 240-4.017(1) is waived.
- 3. This order shall become effective on March 2, 2019.
- 4. This file shall be closed on March 3, 2019.
