On January 24, 2019, Summit Natural Gas of Missouri, Inc. ("Company") filed an application seeking an order from the Missouri Public Service Commission ("Commission") finding that the Commission lacks jurisdiction over this matter or, in the alternative, approving the proposed corporate restructuring described in the application. On February 22, 2019, the Commission's Staff filed a recommendation to approve the proposed corporate reorganization, but subject to a condition relating to Staff's access to Summit Utilities, Inc.'s books, records, and information. The Commission will direct the Company to file a response addressing the condition proposed by Staff and provide an opportunity for any other party to object or comment on the proposed condition.

THE COMMISSION ORDERS THAT:

1. Summit Natural Gas of Missouri, Inc. shall respond to Staff's recommendation, specifically addressing the condition set out therein, no later than March 4, 2019.

- 2. Any other party wishing to respond to the proposed condition in the Staff recommendation shall do so no later than March 4, 2019.
