COME NOW the Parties to this proceeding, and in compliance with the Commission's Order Setting Prehearing Conference and Requiring Filing of Procedural Schedule, respectfully submit the following proposed procedural schedule. In support of their request that the Commission adopt this procedural schedule the Parties state:

1. On April 20, 2001, Complainants TXU Energy Services and Schreiber Foods, Inc., filed their complaint with The Missouri Public Service Commission (Commission).
2. On May 9, 2001 the Commission issued its Notice of Complaint and instructed Missouri Gas Energy, a division of Southern Union Company, (MGE) to answer the Complaint.
3. On June 7, 2001, MGE filed its Answer to the Complaint.
4. In its June 27, 2001 *Order Setting Prehearing Conference and Requiring Filing of Procedural Schedule*, the Commission ordered the Parties to file a proposed schedule no later than July 16, 2001.

5. The Parties respectfully request that the Commission adopt the following procedural schedule:




WHEREFORE, the parties to this case request that the Commission issue an order adopting the above proposed procedural schedule.




