### ORDER DIRECTING FILING

On November 16, 2001, the Commission convened a prehearing conference to address a Motion to Compel Discovery filed by the Staff of the Commission on November 1. At the prehearing conference, Staff advised that it had received the outstanding Data Request responses and that it no longer sought to enforce its motion. Also at the prehearing conference, Petitioners TXU Energy Services, Inc., and Schreiber Foods, Inc., informed the presiding officer that they consented to the issuance of an order requiring that outstanding Data Request responses owed to Respondent Missouri Gas Energy be provided no later than November 27. Respondent Missouri Gas Energy concurred.

In view of the agreement of the parties, the Commission will order Petitioners to provide complete responses to all of Respondent's Data Requests, already overdue as of November 16, to Respondent on or before November 27, 2001.

#### IT IS THEREFORE ORDERED:

- 1. That Petitioners TXU Energy Services, Inc., and Schreiber Foods, Inc., shall provide to Respondent Missouri Gas Energy full and complete responses to all of Respondent's Data Requests which were already overdue as of November 16, 2001, on or before November 27, 2001.
  - 2. That this order shall become effective on November 27, 2001.
