## ORDER SETTING PROCEDURAL CONFERENCE

On July 31, 2017, William Gehrs, Jr., filed a formal complaint against The Empire District Electric Company. On November 7, 2018, the Commission granted Complainant's request to further stay the formal complaint until February 10, 2019. On February 1, 2019, Mr. Gehrs notified this judge and the parties that he would be unavailable until March 1, 2019.

This matter is ready to be set for hearing. In order to discuss a new procedural schedule, the Commission will set a procedural conference. In addition, for the convenience of the parties, they may appear by telephone as set out below.

### THE COMMISSION ORDERS THAT:

1. The parties shall appear at a procedural conference to be held on March 12, 2019, at 10:00 a.m. Failure to appear at the conference without being excused may result in a default being issued in accordance with Commission Rule 4 CSR 240-2.090(5).

2. The procedural conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. Any party may participate in the procedural conference by telephone by dialing (573) 526-5808 or (866) 630-9351 at the start time of the conference.
