Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, the Office of the Public Counsel, and the Missouri Industrial Energy Consumers (MIEC) filed a motion on February 27, 2019, asking the Commission to make additional modifications to the Report and Order issued on April 19, 2012 regarding Ameren Missouri's continued participation in the Midcontinent Independent System Operator, Inc. (MISO). The movants ask the Commission to rule on their motion by March 29, 2019. Given the request for expedited treatment, the Commission will establish a shortened time for the other parties to respond to that motion.


