### ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On February 26, 2019, the Staff of the Missouri Public Service Commission (the "Staff") filed a motion requesting that the certificate of interexchange service authority of Sage Telecom Communications, LLC (the "Company") be cancelled at the request of the Company.

The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion. The Commission finds that proper persons shall be allowed 11 days from the issuance of this order to file a motion for hearing.

#### THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or to request a hearing shall do so by filing a pleading no later than March 11, 2019, with:
