On December 18, 2018, Missouri-American Water Company ("MAWC") filed an application requesting a Certificate of Convenience and Necessity ("CCN") to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in the Timber Springs Estates subdivision in Clinton County, Missouri.

On December 28, 2018, the Commission issued notice of the application, and on February 11, 2019, the Commission's Staff filed a recommendation to approve the CCN.

On February 21, 2019, the Office of the Public Counsel ("OPC") filed a response to the recommendation stating in part that OPC is concerned that MAWC requests approval of an area beyond the Timber Springs Subdivision, and that OPC is seeking additional information from MAWC. OPC stated that it will promptly file its comments concerning Staff's recommendation, but offered no indication as to when that might occur.

The Commission will direct OPC to file a date certain that it will respond to Staff's recommendation.
