ORDER APPROVING TARIFF REVISION

Issue Date: December 19, 2022

Effective Date: January 1, 2023

On December 2, 2022, The Empire District Electric Company d/b/a Liberty filed tariff sheets to comply with the Commission's November 21, 2022, order approving a stipulation and agreement extending Liberty's Missouri Energy Efficiency Investment Act Cycle 1 an additional year. Those tariff sheets bear an effective date of January 1, 2023. The Commission ordered its Staff (Staff) to file a recommendation about the compliance tariff sheets and set a deadline for responses. Staff filed a recommendation to approve the tariff sheets. No other responses were received.

The Commission has reviewed the compliance tariff sheets and Staff's recommendation and finds that the tariff sheets should be approved. The Commission will approve Liberty's compliance tariff sheets to become effective on January 1, 2023. In addition, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff sheets.
