ORDER GRANTING INTERVENTION

On December 19, 2018, Osage Utility Operating Company (“Osage Utility”) filed an application asking to approve its purchase of the water and sewer systems of Osage Water Company, Reflections Subdivision Master Association, and Reflections Condominium Owners Association. Osage Utility also asks for certificates of convenience and necessity to operate those systems, and asks for an acquisition incentive related to those systems.

Reflection Condominium Owners Association filed an application to intervene. More than ten days has elapsed since that application was filed, and no party objects.¹ The Commission takes up the intervention application unopposed, and finds that the applicant meets the Commission’s intervention standard.² Thus, the Commission grants the intervention request.

THE COMMISSION ORDERS THAT:

1. The above-referenced application to intervene is granted.


