ORDER GRANTING APPLICATIONS TO INTERVENE

Union Electric Company d/b/a Ameren Missouri filed its 2023 Integrated Resource Plan (IRP) on September 26, 2023. On September 28, and October 10, 11, 17, 18, and 19, the Missouri Industrial Energy Consumers, Sierra Club, Dutchtown South Community Corporation, the Missouri Joint Municipal Electric Utility Commission d/b/a Missouri Electric Commission, Homes for All St. Louis, The Missouri State Conference of the National Association for the Advancement of Colored People, respectively, filed separate applications to intervene.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless otherwise ordered by the Commission. More than ten days have passed and no party has responded to any of the applications to intervene.

Commission Rule 20 CSR 4240-2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing each of these applicants to participate in the review
