**THE COMMISSION ORDERS THAT:**

1. The evidentiary hearing will occur on April 23, 2019, at 9:30 a.m. The hearing will be held at the Commission's offices in the Governor Office Building, Room 305, 200 Madison Street, Jefferson City, Missouri, a facility that meets the accessibility standards of the Americans with Disabilities Act (ADA). 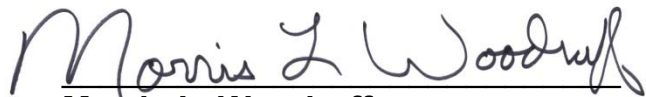
