ORDER GRANTING REQUEST FOR EXTENSION

On November 29, 2021, the City of St. Robert, Missouri, and Laclede Electric Cooperative (Laclede), jointly filed an application (Joint Application) seeking Commission approval of an addendum to an existing territorial agreement. The Commission directed the Staff of the Commission (Staff) to provide its recommendation or a request for an extension of time on or before January 18, 2022.

Staff timely requested an extension of time due to outstanding data requests Staff has submitted to the parties. Those data requests are due February 2, 2022. Accordingly, Staff requests an extension to file its recommendation until February 8, 2022.

Due to the impact the additional information may have on Staff's report, the Commission finds the extension request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall file its recommendation on or before February 8, 2022.
2. This order shall be effective when issued.
