On April 14, 2022, Liberty submitted its 2021 Renewable Energy Standards ("RES") Compliance Report and 2022-2024 RES Compliance Plan, pursuant to Commission Rule 20 CSR 4240-20.100(8). Staff filed its report on June 1, 2022.
