ORDER GRANTING REQUEST TO SUBMIT A CORRECTED 2021 RES COMPLIANCE REPORT

On April 14, 2022, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) submitted its 2021 Renewable Energy Standards (“RES”) Compliance Report and 2022-2024 RES Compliance Plan, pursuant to Commission Rule 20 CSR 4240-20.100(8). The rule requires the Staff of the Commission to review RES compliance reports and plans and file a report of its review with the Commission within 45 days of the date of filing. On May 26, 2022, Staff requested an extension of time to submit its report, and the Commission issued its order granting Staff’s request on the same day, setting the deadline no later than July 15, 2022.

On July 5, 2022, Ameren Missouri filed its *Request to Submit a Corrected 2021 RES Compliance Report*, stating that it has been consulting with Staff, and that its only correction is the replacement of the table found under Section (8) (A) 1 I: RECs from Non-Owned Utility Resources on page 10.

The Commission finds Ameren Missouri’s request to submit its corrected compliance report to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri's Request to Submit a Corrected 2021 RES Compliance Report is granted.
2. This order shall be effective when issued.
