ORDER APPROVING COMPLIANCE TARIFF SHEETS

On October 16, 2023,¹ Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (together, “Evergy”) filed tariff sheets which were assigned Tracking Nos. JE-2024-0047 and JE-2024-0048, respectively. The sheets have an effective date of November 15.

The tariff sheets are compliance filings pursuant to an Order Approving Four Partial Stipulations and Agreements (Order). The tariff sheets are in regards to the Critical Needs program and the Rehousing Pilot program.

On October 31, the Staff of the Commission (Staff) recommended that the Commission approve the tariff sheets. No other responses to the tariff sheets were received.

Upon reviewing the pleadings, the Commission finds Evergy's proposed tariff sheets comply with the Commission's Order and will approve them. To enable the tariff to become effective on the date requested by Evergy, the Commission finds it reasonable to make this order effective in less than 30 days.

1. The proposed tariff sheets filed on October 16, and assigned Tracking Nos. JE-2024-0047 and JE-2024-0048 are approved to become effective on November 15.
