## ORDER GRANTING EXTENSION OF TIME

This file is a request to change electric supplier from Every Missouri West, Inc. (EMW) to Platte-Clay Electric Cooperative, Inc. (Platte-Clay). The Commission directed the parties to submit a proposed procedural schedule leading to an evidentiary hearing or a status report no later than December 23, 2022.

On December 22, 2022, the Staff of the Commission (Staff) filed a status report, which indicated the possibility of a proposed settlement. Staff requested an extension to allow for circulation and evaluation of the proposal. Staff asks that the Commission allow the parties until January 20, 2023, to file either a proposed procedural schedule or another status report.

The Commission finds that the request is reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. No later than January 20, 2023, the parties shall submit a status report or a joint proposed procedural schedule.
2. This order shall be effective when issued.
