**STATUS REPORT**

**COMES NOW** Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers” or “Company”) and for its *Status Report* respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. On July 12, 2023 (effective July 22, 2023), the Commission issued its *Order Approving Acquisition of Assets and Granting a Certificate of Convenience and Necessity* (“Order”) in this case. The Order approves the acquisition of, and grants a Certificate of Convenience and Necessity for, the sewer system assets of Kenneth Jaeger, located near the Lost Valley subdivision in Ralls County, Missouri (“Lost Valley”).

2. The Order further directs Confluence Rivers to notify the Commission of closing on the assets in this case or file a status report if closing has not yet occurred within thirty days of the effective date of the Order, and additional Status Reports each subsequent thirty-day period until closing takes place.

3. Confluence Rivers has not yet closed on the assets of Lost Valley but continues to work toward such closing.

4. Confluence Rivers will provide notice of closing on the assets to the Commission as soon as the assets of the Lost Vally system are closed upon.

**WHEREFORE**, Confluence Rivers respectfully submits this *Status Report* to the Commission.
