ORDER DIRECTING FILING OF STAFF RECOMMENDATION

On November 1, 2023, Chariton Valley Telephone Corporation and Chariton Valley Broadband, LLC (collectively “Joint Applicants”) requested transfers of its Certificate of Public Convenience and Necessity¹ to provide telecommunications services as well as its designation as an Eligible Telecommunications Carrier (ETC) in the state of Missouri. The transfers are part of a corporate restructuring that involves a transfer of all assets. Chariton Valley Broadband, LLC is a wholly-owned subsidiary of Chariton Valley Telephone Corporation.

The Commission will direct that its Staff file a recommendation regarding this application.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation regarding this application, or a statement of when it expects to file a recommendation, no later than December 4, 2023.
