## ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On November 3, 2023, Summit Natural Gas of Missouri, Inc. filed tariff sheets to reflect changes in the company's Regular Purchased Gas Adjustment clause. The tariff sheets had an effective date of November 13, 2023, which the company extended to November 14, 2023.

In consideration of the effective date of the tariff sheets, the Commission will direct the Staff of the Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets.

#### THE COMMISSION ORDERS THAT:

- 1. No later than November 9, 2023, Staff shall file either its recommendation with regard to Tariff File No. JG-2024-0057 or a status report indicating when it expects to file its recommendation.
- 2. Any other entity wanting to respond to the tariff sheets shall do so no later than November 9, 2023.
