**COMPANY SERVICES**Emergency Telecommunications Services (9-1-1 Emergency Services)

9-1-1 Emergency Services are telecommunications services that permit a Public Safety Answering Point (PSAP) to receive emergency calls placed by dialing the number 9-1-1, and/or permit emergency calls originated by personal communications devices.

9-1-1 Emergency Services include 9-1-1 Routing and Transfer Services that use a call routing system to either directly perform the selective routing of an emergency call to the appropriate PSAP, or may be used to hand-off the call to a separate 9-1-1 Service Provider for call completion to the appropriate 9-1-1.

9-1-1 Emergency Services include a data management service, a call delivery service, a call routing service, and a 9-1-1 Automatic Location Identification (ALI) service. The Customer is the Governing Authority that orders service and is responsible for the payment of the charges and compliance with the terms and conditions of the contracts entered into with Intrado Safety Communications, Inc.

Intrado Safety Communications, Inc. concurs in the telephone exchange boundary maps of Missouri incumbent local exchange carriers. To the extent applicable, Intrado Safety Communications, Inc. recognizes Missouri Public Service Commission Rule 4 CSR 240-34 – Emergency Telephone Service Standards. Facilities used in the provision of Intrado Safety Communications, Inc.’s services are constructed to meet specifications negotiated by the Company and the Customer on an Individual Case Basis. All charges are offered to Customers in writing and on a nondiscriminatory basis. Copies of Intrado Safety Communications, Inc.’s service contracts will be made available to the staff of the Missouri Public Service Commission as requested on a proprietary basis.

Service is provided pursuant to contracts negotiated with the Customer. Service descriptions and rates are included in contracts along with terms and conditions of service, payment requirements, and limitations of liability.
