## ORDER SUSPENDING PROCEDURAL SCHEDULE

On November 1, 2023,<sup>1</sup> the Commission issued an order amending the procedural schedule in this matter due to hospitalization of a witness. Among other changes, the amended procedural schedule extended the deadline for surrebuttal/cross-surrebuttal testimony from November 3 to November 9.

On November 6, Union Electric Company d/b/a Ameren Missouri filed an *Unopposed Motion to Suspend Procedural Schedule and Motion for Expedited Treatment*. The motion requests suspension of the procedural schedule – including the current evidentiary hearing dates – due to re-hospitalization of the same witness that necessitated the November 1<sup>st</sup> amendment of the procedural schedule. If its motion is granted, Ameren Missouri anticipates that the parties will later file a joint proposed amended procedural schedule. No parties oppose the motion.

The Commission will grant Ameren Missouri's motion.
