**ORDER DIRECTING STAFF RECOMMENDATION
AND SETTING TIME FOR RESPONSES**

On November 3, 2023, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed tariff sheets to reflect changes in the company's Winter Purchased Gas Adjustment for its four service areas. The tariff sheets bear an effective date of December 3, 2023.

In consideration of the effective date of the tariff sheets, the Commission will direct the Staff of the Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than November 16, 2023, Staff shall file a recommendation with regard to Tracking No. JG-2024-0059.
2. Any other entity wanting to comment on the tariff sheets or respond to Staff's recommendation shall do so no later than November 20, 2023.

3. This order shall be effective when issued.
