RESPONSE TO ORDER

COMES NOW Staff of the Missouri Public Service Commission (Staff), by and through undersigned counsel, and for its *Response to Order* (*Response*) in this matter hereby states:

1. KCP&L Greater Missouri Operations (GMO) filed its Limited Large Customer Economic Development Discount Rider tariff sheets with the Commission on August 27, 2018, bearing an effective date of September 26, 2018.

2. Staff filed and the Commission granted a *Motion to Suspend Tariff Sheet* and Open New Docket (Motion) on September 25, 2018.

3. GMO filed on October 4, 2018, substitute tariff sheets (*Substitute Tariff Sheets*) with a 30-day effective date; GMO also requested expedited treatment of the *Substitute Tariff Sheets*, such that the *Substitute Tariff Sheets* become effective on October 19, 2018.

4. The Commission issued an order on October 5, 2018, allowing for responses to the motion for expedited treatment and approval of the substitute tariff sheets.

5. GMO filed on October 9, 2018, revised *Substitute Tariff Sheets* (*Second Substitute Tariff Sheets*) and withdrew its October 4 request for expedited treatment.

6. GMO filed on October 18, 2018, further revised *Substitute Tariff Sheets* (*Third Substitute Tariff Sheets*).

7. The Commission issued an order on October 19, 2018, allowing for responses to the substituted tariff sheets filed on October 18.

8. While Staff's *Motion* identified a potential substantive dispute regarding the proposed tariff sheets, that potential substantive dispute has been resolved with the filing of the *Third Substitute Tariff Sheets*.

WHEREFORE, Staff requests that the Commission order approval of the tariff sheets contained in JE-2019-0026, as substituted.
