ORDER DIRECTING STAFF REPORT

On September 1, 2021, the Commission directed its Staff to investigate Spire Missouri, Inc. d/b/a Spire's compliance with the Commission's gas safety rules related to the mechanical joining qualifications of its employees. The Commission ordered its Staff to file progress reports regarding its investigation.

In its sixth progress report on October 26, 2023, Staff explains that its investigation is proceeding and asks that it be directed to file either a report regarding its investigation, or a further progress report, no later than November 15, 2023. The Commission will order Staff to file a further report.

THE COMMISSION ORDERS THAT:

1. Staff shall file either a report regarding its investigation, or a report on the investigation's progress, no later than November 15, 2023.
2. This order shall be effective when issued.
