On October 30, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed tariffs in an effort to comply with the Commission’s October 18, 2023 Order Approving Transfer of Assets and Order Granting Certificate of Convenience and Necessity. Those tariffs, Tracking Nos. JW-2024-0053 and JS-2024-0054, bear effective dates of November 29, 2023.

Staff filed its Recommendation on November 7, 2023, advising the Commission to approve most of the tariff sheets. Staff stated that two tariff sheets should be rejected because those tariff sheets were not revised. Confluence responded on November 7, 2023 by withdrawing the two tariff sheets in question. Confluence also asked that the remaining tariff sheets become effective by November 20, 2023.

The Commission will allow time for objections to Confluence’s request for a November 20, 2023 effective date for the tariff filings.

THE COMMISSION ORDERS THAT:

1. Any objections to Confluence request for expedited treatment of the tariffs shall be filed no later than November 8, 2023.

2. This order shall be effective when issued.


