**JOINT REQUEST FOR AN EXTENSION OF TIME TO FILE A PROCEDURAL
SCHEDULE OR STATUS REPORT**

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”), Staff of the Missouri Public Service Commission (“Staff” and “Commission,” respectively), the Office of Public Counsel (“OPC”), and the Missouri Coalition for Fair Competition and Corey Malone (“Coalition”) (collectively, “Parties”), and jointly propose an extension until December 12, 2023, to file a procedural schedule or a status report.

1. In its October 12, 2023, Order, the Commission directed the Parties to file a procedural schedule on November 8, 2023. On November 3, 2023, the Parties to this case conducted a procedural conference to discuss a procedural schedule that would enable the Commission to consider this complaint. While the Parties were able to discuss a tentative schedule, the Parties agreed that extra time is needed to file a proposed schedule in the event the matter can be resolved through a settlement.

2. The Parties have scheduled a settlement conference on November 15, 2023.

3. In the event the Parties require more time to reach an agreement on the schedule or agreement to resolve this matter, the Parties will file a status report with the Commission and provide a new date in which a procedural schedule will be filed.

WHEREFORE, the Signatories to this pleading request the Commission allow an extension to file a proposed procedural schedule or status report to December 12, 2023.
