133. Daronn Williams's direct testimony in WR-2023-0344 states that "new company trucks were purchased in February 2023". Please provide all data and information the Company provided Staff regarding the purchase of new company trucks, including but not limited to:
a) The timeline for purchasing new company trucks;

Staff does not know the exact date each vehicle was purchased. See below for the date the vehicles were added to the Company's general ledger. Mr. Williams mistakenly stated the vehicles were purchased in February 2023. Safety features were added to the trucks in February 2023. This will be corrected in his Rebuttal Testimony.
