On May 24, 2022, The Empire District Electric Company, a Liberty Utilities company (Empire-Liberty) filed a tariff to implement a second Community Solar Pilot Program facility. The tariff, denominated Tariff No. YE-2022-0261, bore an effective date of July 1.

On June 7, 2022, the company extended the tariff's effective date to July 11, 2022.

The Commission will order responses.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a Recommendation on Tariff No. YE-2022-0261 no later than June 21, 2022.
2. Any response to the Staff Recommendation shall be filed no later than June 23, 2022.
3. This order shall be effective when issued.
