On October 26, 2023, The Empire District Electric Company d/b/a Liberty filed a revised tariff entitled Limited Large Customer Economic Development Rider, Schedule SBEDR. The tariff bears a November 25, 2023 effective date.

The Commission ordered responses no later than November 9, 2023. On November 9, 2023, the Staff of the Commission filed a Motion for Extension. In that motion, Staff explains that the Office of the Public Counsel (OPC) has been in contact with suggestions. Staff asks for an additional week to review OPC's suggestions.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension is granted.
2. The Staff of the Commission shall file a Recommendation regarding the amended application no later than November 16, 2023.
3. Any other party who wishes to respond to the amended application shall do so no later than November 16, 2023.
