## ORDER APPROVING TARIFFS

Issue Date: November 9, 2023

Effective Date: November 20, 2023

On October 30, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed tariffs in an effort to comply with the Commission's October 18, 2023 Order Approving Transfer of Assets and Order Granting Certificate of Convenience and Necessity. Those tariffs, Tracking Nos. JW-2024-0053 and JS-2024-0054, bear effective dates of November 29, 2023.

Staff filed its Recommendation on November 7, 2023, advising the Commission to approve most of the tariff sheets. Staff stated that two tariff sheets should be rejected because those tariff sheets were not revised. Confluence responded on November 7, 2023, by withdrawing the two tariff sheets in question.<sup>1</sup>

Confluence also asked that the remaining tariff sheets become effective by November 20, 2023. Confluence has requested expedited treatment because its pending general rate case requires consolidation of its tariff books, and Confluence would like the tariffs in this file effective in time to put into its new

tariff books. Staff responded on November 8, 2023, advising that it did not object to the tariff sheets becoming effective by November 20, 2023.

Having reviewed the pleadings, the Commission will approve the tariff sheets. The Commission further finds good cause exists to allow these compliance tariffs to become effective in less than thirty days.

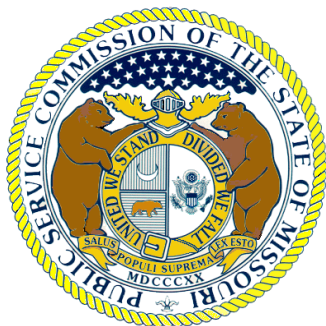
