## ORDER REGARDING CLARIFICATION AND NOTICE OF DEFICIENCY

On November 8, 2023, Brett Felber filed an application with the Missouri Public Service Commission requesting a change of electric supplier from Union Electric Company d/b/a Ameren Missouri to “Evergy”. As “Evergy” is the name of two electric corporations in the state of Missouri - Evergy Missouri West, Inc. and Evergy Missouri Metro, Inc.- neither of which has a service territory on the eastern side of the state where the subject address is located, the Commission will direct the applicant to clarify the application by providing the intended entity to which the application refers.<sup>1</sup> The Commission will take no action on this application until clarification is filed by the applicant.

### THE COMMISSION ORDERS THAT:

1. The Commission will take no action with regard to this application until clarification is filed by the applicant as set out in the body of this order.
2. This case may be dismissed in accordance with 20 CSR 4240-2.116(2) for lack of prosecution if no action has occurred or no continuance has been requested by February 7, 2024.
