On March 11, 2019, the Office of Public Counsel (“OPC”) filed a *Response to Staff’s Eighth Prudence Review Report, Request for an Evidentiary Hearing, and Request for Consolidation*. Specifically, OPC requested that File No. ER-2019-0198 be consolidated with this case for hearing and decision. The Commission will order the Staff of the Missouri Public Service Commission and KCP&L Greater Missouri Operations to file responses to OPC’s request for consolidation.

1. The Staff of the Missouri Public Service Commission and KCP&L shall each file responses to the Office of Public Counsel’s request to consolidate File No. ER-2019-0198 with this file no later than March 22, 2019.


