**ORDER GRANTING EXTENSION OF TIME
TO FILE STAFF RECOMMENDATION**

On September 22, 2023, Spire Missouri Inc. (Spire) filed an application that seeks a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide natural gas service in Cass County, Missouri, as a further expansion of Spire’s existing certificated area. Spire also requested waiver of the Commission’s rule requiring 60 days’ notice prior to filing an application.

On September 22, 2023, the Commission issued an order that, among other things, directed its Staff to, by November 8, 2023, file a recommendation regarding Spire’s application or request an extension of time to do so.

On November 7, 2023, Staff filed a *Motion for Extension of Time to File Staff Recommendation* asking for an additional 30 days in which to file its recommendation. As none of the other parties in this matter oppose the motion, the Commission will grant Staff’s motion.

THE COMMISSION ORDERS THAT:

1. Staff's *Motion for Extension of Time to File Staff Recommendation* is granted.
2. No later than December 7, 2023, Staff shall file a recommendation regarding Spire's application or a request for an extension of time.
3. This order shall be effective when issued.
