NOTICE REGARDING TARIFF

Issue Date: January 19, 2023

On December 21, 2022, Union Electric Company d/b/a Ameren Missouri filed a tariff revision to modify its temporary service provisions such that service to new customers can commence using estimated billing determinants in cases where customer-requested new or upgraded service is being delayed by insufficient stock of metering transformers. Customers receiving this form of service will be converted to standard metered service as equipment becomes available.

Ameren Missouri initially filed its tariff on December 21, 2022, with an effective date of January 20, 2023. The company filed a substitute tariff sheet on January 17, 2023, and made that filing this case. Ameren Missouri explained that Staff asked it to file the tariff in a new case to create a repository to track future developments regarding the tariff.

On January 18, 2023, Staff filed a recommendation advising the Commission to allow the tariff to become effective by operation of law on its January 20, 2023 effective date.
