# ORDER DIRECTING FILING OF STAFF RECOMMENDATION REGARDING REVISED TECHNICAL RESOURCE MANUAL

On March 12, 2019, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company ("Company") filed a request to modify the Company's Technical Resource Manual in the Company's MEEIA Cycle 2 program. The Commission will direct its Staff to review the request and submit a recommendation. The Commission will also provide an opportunity for other parties to comment on the Company's request.

The Company has requested that the Commission approve the modifications to the Technical Resource Manual to be effective on April 1, 2019, although the Company has not asked for expedited treatment or explained why that effective date is important. The Commission will shorten the usual time for responses from Staff and other parties in order to take action as close to April 1 as possible. However, the Commission will also permit Staff to file a status report in place of a recommendation if it needs additional time to review the Company's request.

## THE COMMISSION ORDERS THAT:

1. No later than March 20, 2019, Staff shall review the request to modify Technical Resource Manual submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company and file a recommendation as to whether that request should be approved. In the alternative, Staff may file a status report instead of a recommendation by that date if it determines that it requires additional time to review the request.

2. Any party wishing to respond or comment on the request to modify Technical Resource Manual submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file its response no later than March 20, 2019.

3. This order shall be effective when issued.
