**ORDER ESTABLISHING
TIME TO RESPOND TO MOTION**

On March 14, 2019, the Staff of the Missouri Public Service Commission (the “Staff”) filed a motion requesting that the certificates of interexchange service authority and to provide basic local telecommunications services of Global Connection, Inc. (“Company”) be cancelled at the request of the Company. Staff states that the Company wishes to voluntarily relinquish all of its wireline authority, effective May 5, 2019, in Missouri, but wishes to retain its authorization to provide wireless services and to operate as a wireless eligible telecommunications carrier (ETC).¹

The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.² Therefore, if no request for a hearing or objection to Staff’s motion is received, the Commission may cancel the certificates based on Staff’s motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
