ORDER SHORTENING TIME FOR RESPONSES AND DIRECTING FILING

Effective Date: February 6, 2023

On January 17, 2023, the Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a tariff sheet, assigned Tracking No. JE-2023-0132, designed to revise Evergy Missouri West's rates paid for energy for cogeneration as required by Commission Rule 20 CSR 4240-3.155. The tariff sheet has an effective date of February 16, 2023.

On February 3, 2023, the Staff of the Commission filed a motion to suspend the tariff sheet and a motion for expedited treatment. Staff requested the Commission suspend the tariff sheet to allow sufficient time for Staff to examine the validity of the assumptions Evergy Missouri West used in setting the cogeneration rate and make an informed recommendation to the Commission. Staff did not state how long it expects to need to formulate its recommendation.

Because the tariff sheet is set to become effective on February 16, 2023, the Commission will shorten the time for responses to Staff's motions. Additionally, the Commission will direct Staff to provide an estimate of when it expects to file its recommendation.

THE COMMISSION ORDERS THAT:

1. Any responses to Staff's motion to suspend and motion for expedited treatment shall be filed no later than February 8, 2023.
2. Staff shall provide an estimate of when it expects to file its recommendation no later than February 8, 2023.
3. This order shall be effective when issued.
