ORDER GRANTING EXTENSION TO FILE

On March 15, 2019, The Empire District Electric Company filed a Motion for Extension of Time seeking additional time to file its 2019 Integrated Resource Plan, which is required by the Commission's Electric Utility Resource Planning Rule, 4 CSR 240-22. By that rule, Empire's filing is to be made by April 1, 2019. Empire asks that it be allowed until July 1, 2019 to make that filing, explaining that it needs more time to incorporate distributed energy resources (DERs) into its modeling. The motion represents that Empire has contacted all parties to this case and that none object to the requested extension.

The Commission finds that the unopposed request for extension is reasonable. That request will be granted.

THE COMMISSION ORDERS THAT:

1. The due date for the submission of The Empire District Electric Company's 2019 triennial integrated resource planning filing is extended from April 1, 2019, to July 1, 2019.

2. This order shall be effective when issued.
