ORDER SHORTENING TIME FOR RESPONSE

On March 15, 2019, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets and a Motion for Expedited Treatment. The changes to the WNAR tariff sheets will reduce rates to Liberty Utilities' residential and small general service customers. Liberty Utilities had previously been granted a temporary variance from the provisions of its tariff that would have required this filing be made on March 1, 2019, instead of March 15, 2019. Liberty Utilities requests that the Commission now grant expedited approval of the revised tariff sheets so that the rate reduction can take effect on April 1, 2019, as contemplated in the tariffs, rather than April 15, 2019, the effective date of the proposed tariff sheets. The motion represents that Staff has no objection to the motion for expedited treatment being granted.

The Commission will direct Staff to file a recommendation and shorten the time to respond to the motion for expedited treatment and to the proposed tariff changes.

THE COMMISSION ORDERS THAT:

- 1. No later than March 22, 2019, the Staff of the Commission shall file a recommendation regarding Tariff Track No. JG-2019-0170.
- 2. Any responses to the motion for expedited treatment filed on March 15, 2019, shall be filed no later than March 22, 2019.
 - 3. This order is effective when issued.
