On September 28, 2023,¹ Dranel J. Clark and Aquilla Canada (“the Complainants”) filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri.

On October 25, the Commission issued an order, which, among other things, directed its Staff to investigate the complaint and file a report no later than November 13. On November 9, Staff filed a *Motion for Extension* in which it asked for an extension to December 20 to complete its investigation and file its report. None of the parties object to Staff’s request.

The Commission finds the motion reasonable and will grant it.
