### NOTICE REGARDING REVISED TARIFF SHEETS

Issue Date: March 20, 2019

On February 12, 2019, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (collectively, the "Company") filed applications for approval to revise their existing tariffs relating to Residential Time of Use ("TOU"). The Company filed revised TOU tariff sheets, which carry an effective date of April 5, 2019, under Tariff Tracking Nos. YE-2019-0166 and YE-2019-0167. The Company's applications also request approval of revisions to its Standby Service Rider ("SSR") tariff sheets, but those tariffs have not yet been filed. The Company's existing TOU and SSR tariff sheets were filed and approved by the Commission as part of stipulations and agreements in the Company's most recent rate cases, File Nos. ER-2018-0145 and ER-2018-0146. The Company alleges that revisions to the existing TOU and SSR tariffs are necessary because those tariffs do not adequately capture the intent of all aspects of the stipulations and agreements.

On March 6, 2019, the Commission's Staff filed a recommendation and memorandum regarding the applications. Staff states that the Company's proposed

revisions to the TOU tariffs exclude holidays from the "on-peak" definition of 4 p.m. to 8 p.m. on Monday through Friday. The proposed change would apply the rate for usage during the otherwise on-peak portion of weekday holidays from the seasonally-appropriate on-peak rate to the seasonally-appropriate off-peak rate. The TOU rates are not available to customers until October 1, 2019, so no customers currently take service under those tariff sheets.

Staff states that from a policy perspective it does not oppose the revised TOU tariff sheets, and recommends that the Commission allow the TOU tariff sheets to take effect by operation of law. Since Staff continues to examine the proposed revisions to the SSR tariffs and no revised SSR tariff sheets have yet been filed, Staff recommends that the Commission take no action at this time relating to the SSR revisions in the applications. Staff has verified that the Company has filed its 2017 annual reports and is not delinquent on any assessment. No party has objected to the revisions to the TOU tariff sheets.

The Commission finds that the revised TOU tariff sheets are compliant with all applicable statutes and regulations, so in accordance with Staff's recommendation, the Commission will allow the revised TOU tariff sheets in Tariff Tracking Nos. YE-2019-0166 and YE-2019-0167 to become effective on April 5, 2019 by operation of law.
