# **ORDER GRANTING MOTION FOR EXTENSION**

On August 25, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed applications seeking, among other things, authority for Confluence to acquire and operate the water and sewer systems of Lake Sherwood Estates.<sup>1</sup> The Commission ordered its Staff to file a Recommendation or a Status Report no later than November 28, 2023.

On November 14, 2023, Confluence filed a Motion for Extension of Staff's Time to File a Recommendation (Motion). Confluence states that it has been unable to respond to Staff Data Requests due to a family health emergency. Thus, Confluence asks for Staff to receive an extension of time until January 11, 2024 to file its Recommendation.

The Commission finds the motion reasonable, and will grant it.

1. Confluence's Motion is granted.
