**ORDER DIRECTING NOTICE AND
ESTABLISHING TIME FOR RESPONSES**

On March 20, 2019, Union Electric Company d/b/a Ameren Missouri filed a request for a variance of Commission rule 4 CSR 240-20.094(7)(K). Ameren Missouri's filing included a motion for expedited treatment requesting a decision to be issued by April 5, 2019 (16 days after the request was filed). Ameren Missouri asks the Commission to grant it a variance from the requirement that customers who previously opted-out of a demand-side program and now want to opt back in must file such notice two to four months in advance of the calendar year they want to resume participation.

THE COMMISSION ORDERS THAT:

1. Any party or entity wishing to respond to Union Electric Company d/b/a Ameren Missouri's Request for Variance from 4 CSR 240-20.094(7)(K) or Request for Expedited Consideration shall do so no later than March 28, 2019.
2. The Staff of the Commission shall file a Recommendation no later than April 2, 2019.

3. This order shall be effective when issued.
